Thank you for the information you shared with me yesterday regarding fire protection available to Carlton Farms, Inc. for two of our houses on a southward extension of Sauls Road. I apparently misunderstood the limitations of the distance that the city can travel to provide fire protection, but I measured the distance from our house that is farthest south off of Lower Meigs Road to Fire Station No. 2 and it is a little over 3 miles.

You informed me that the city would provide fire protection and could arrange with the West Side Fire Department to have a pumper truck on standby if necessary. You also informed me that you had discussed this situation with "Teresa" with Auto Owner's Insurance. I believe you told me that you had sent Teresa something in writing to that effect and I would appreciate it if you could give me a copy of that.

Under the circumstances, we would like to withdraw our petition for deannexation.
